## **Patient Information**

Your patch test results indicate that you have a contact allergy to copper sulphate. This contact allergy may cause your skin to react when it is exposed to this substance although it may take several days for the symptoms to appear. Typical symptoms include redness, swelling, itching and fluid-filled blisters.

## Where is copper sulphate found?

Copper sulphate is a fungicide and found in treatments to inhibit fungus on grapes, melons, and other berries. It is also found in the horticulture industry to prevent damping off in seedlings. This substance is used in aquariums to treat fish for parasites and remove snails.

## How can you avoid contact with copper sulphate?
